Order : These petitions coming up for orders on this day, upon perusing the petitions filed in support thereof and upon hearing the arguments of MR.M.S.JEYAKARTHIK, Advocate for the petitioner in both petitions and of MR.M.VEERANTHIRAN, Government Advocate (Criminal Side) on behalf of the Respondent in both petitions, the court made the following order:-

These petitions have been filed to modify the condition, whereby the petitioner is directed to pay a sum of Rs.35,000/- to the credit of District Mineral Foundation Trust, Ramanathapuram, made in Crl.OP(MD)No.10759 of 2022, dated 17.06.2022 and extension of further time of 2 weeks for complying the condition.



2. Heard the learned counsel on either side.

3. Considering the facts and circumstances of the case, the condition imposed in Crl.O.P.(MD)No.10759 of 2022, dated 17.06.2022, is modified to the effect that the petitioner shall pay a sum of Rs.10,000/- (Rupees Ten thousand only) to the credit of District Mineral Foundation Trust, Ramanathapuram.

4. Accordingly, the Criminal Miscellaneous Petitions are allowed. The time for surrender and execution of sureties is extended by two weeks from the date of receipt of a copy of this order.
