ORDER

The petitioner has filed the Writ Petition seeking issuance of a Writ of Mandamus, directing the respondents 3 & 5 to issue work order to the petitioner for the upgradation work of Thar Road from Sheep Farm to Graveyard (Mayanakarai) in Kunnur Village, Vathira Iruppu Taluk, Virudhunagar District.

2. The case of the petitioner is that he is the only tenderer to apply the upgradation work of Thar Road from sheep Farm to Graveyear in Kunnur Village, Vathirairuppu Taluk, Virudhunagar District. But, till now, the respondents 3 & 5 have not issued work order to him for the aforesaid work. The petitioner has already paid the necessary amount.
