2. Mr. D. Gandhiraj, learned Special Government Pleader takes notice for the respondents 1 and 2. By consent of both parties, the Writ Petition is taken up for final disposal at the admission stage itself.

3. The case of the Petitioner is that he is doing agricultural works and that he got the petition mentioned properties from his father through Settlement Deed on various dates. The Petitioner has also got patta in Patta No.1820 for the subject property and his name was also registered in the Town Survey Register. In the meantime, one Esakki Muthu purchased the property on the western side from one Chinntha Mathar

and tried to encroach the Petitioner's property by making unnecessary



6. With the above direction, the Writ Petition stands disposed of. No costs.
