2. Heard Mr. Arulvadivel @ Sekar, learned counsel appearing for the petitioner and Mr. Mahaboob Athiff, learned Standing Counsel appearing for the respondents.

3. No prejudice will be caused to the respondents, if the representations of the respective petitioners are considered on merits and in accordance with law.

Accordingly, this Court directs the first respondent to consider the representations made by the petitioners both dated 01.09.2021, seeking for issuance of fresh notification to conduct Second Year M.A. Economic Examination under the old syllabus for the academic year 2016-2017 and pass final orders on merits and in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.

5. With the aforesaid directions, these writ petitions are disposed of. No costs.
