As per the remarks offered by the learned Judicial Magistrate No.II, Ramanathapuram, final report of the investigation in Crime No.236 of 2016 had been filed, on verification, it was found to be defective and therefore, it was returned.

4. Recording the same, the Criminal Original Petition is closed. Consequently, connected Miscellaneous Petition is also closed.
