The petitioner is the accused No.2 in Crime No.876 of 2022 on the file of Thiruvudaimarudhur Police Station, Thanjavur District, and the offences alleged against the accused is under Section 3(2) (va) of Scheduled Caste and Scheduled Tribes (Prevention of Atrocities) Act, 1989 r/w Section 323 of IPC.

2. The present petition filed by the petitioner is to direct the I Additional District and Sessions Judge (PCR) Court, Thanjavur, to accept the surrender of the petitioner and also to consider the bail application on the same day.

- 1) The petitioners should appear before the I Additional District and Sessions Judge (PCR) Court, Thanjavur, within a period of 15 days, from the date of uploading the order copy in the website of this Court *and*
- 2) On such surrender, concerned Sessions Judge, may consider the bail application filed by the petitioners on merits on the same day of surrender, after giving notice to the concerned Public Prosecutor and by complying Section 15(5) of the Act.

5. With the above observation, this Criminal Original Petition is ordered.
