2. Since the vehicle is in the custody of the co-owner, the petitioner could not able to transfer the ownership of the vehicle in favour of the petitioner. He possessed original RC book one in the name of Arumugam and also original sale agreement dated 21.09.2017.

Considering the above, the condition No.6 alone is modified to the effect that the petitioner shall file an undertaking affidavit immediately after return of the vehicle and he shall change the ownership in his favour within a period of eight (8) weeks from the date of taking possession of the vehicle. All other conditions shall remain intact.

4. Accordingly, this Criminal Revision Case is allowed.
