2.Heard the learned counsel for the petitioner, the learned Additional Public Prosecutor appearing for the first respondent and the learned counsel appearing for the second respondent.

3.The defacto complainant and the accused persons are present in person before this Court. They have been duly identified by the prosecution and also the learned counsel for the petitioners. On enquiry, the defacto complainant categorically submits that they are close relatives and in order to maintain cordiality among the family members, he wants to withdraw the complaint against the petitioners.
