2.Heard the learned counsel for the petitioner, the learned Additional Public Prosecutor appearing for the first respondent and the learned counsel appearing for the second respondent.

3.The defacto complainant and the accused persons are present in person before this Court. They have been duly identified by the prosecution and also the learned counsel for the petitioners. On enquiry, the defacto complainant categorically submits that they are belong to one family and the second petitioner is the brother of the defacto complainant and to maintain cordiality among the family members, the de-facto complainant wants to withdraw the complaint against the petitioners. Since the parties have arrived at an amicable settlement, no purpose would be served in keeping the impugned prosecution alive. The parties have also filed a joint compromise memo dated 01.10.2022.
