Honble court may deem fit and proper in the circumstances of the case and thus render justice.

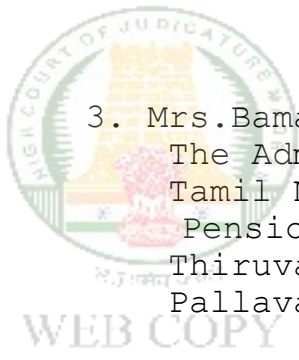
