2. The Writ Petition has been filed in the nature of Mandamus seeking a negative direction to the respondents not to construct a Primary Health Centre in Survey No.43/27, Kariyapatti Village, Virudhunagar District.

3. It is admitted by the learned counsel for the petitioner and also confirmed by Mr.S.Kameswaran, learned Government Advocate, that Survey No.43/27 does not belong to the petitioner. The actual survey number which is in his holding is 45/27A.



4. Mr.S.Kameswaran, on instructions, stated that the Primary Health Centre is not going to be constructed at Survey No.45/27A. They are however going to construct the Primary Health Centre in Survey No.45/11.
