PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

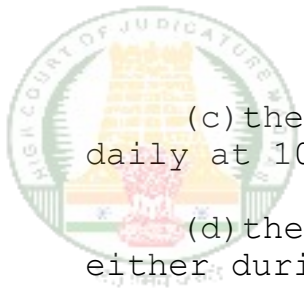
PRAYER :- For Anticipatory bail in Crime No.383 of 2022 on the file of the Respondent police.

ORDER : The Court made the following order :-

The petitioners/A1 to A11, who apprehend arrest at the hands of the respondent police for the offences punishable under Sections 143, 341, 427, 294(b) and 506(i) IPC, in Crime No.383 of 2022, seek anticipatory bail.

2.The case of the prosecution is that the de-facto complainant is working as Joint Secretary of DMK Political Party at

(c)the petitioners shall report before the responder daily at 10.30 am until further orders.

(d)the petitioners shall not tamper with evidence or witness either during investigation or trial;

(e)the petitioners shall not abscond either during investigation or trial;

(f)on breach of any of the aforesaid conditions, the learned Magistrate/ Trial Court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions have been imposed and the petitioners released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji Vs. State of Kerala [(2005) AIR SCW 5560]**; and;

(g)if the accused thereafter abscond, a fresh FIR can be registered under Section 229-A IPC.
