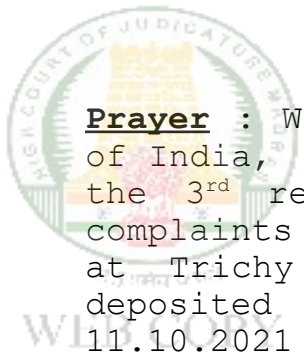

3.When the matter was taken up for hearing, the learned Additional Public Prosecutor submitted that already Crime No.1 of 2021 was registered on the file of the Inspector of Police, E.O.W-II, Trichy and that the petitioner also will be cited as one of the witnesses. The petitioner apprehends that the fifth respondent may tweak the petitioner's statement to be recorded. I make it clear that the fifth respondent will record the petitioner's statement as it is stated. It is open to the petitioner herein to send a copy of the statement by registered post and thereafter appear in person before the fifth respondent and give a statement in person on the same lines. Be that as it may, the fifth respondent is directed to file the final report on merits and in accordance with law within a period of six months from the date of receipt of a copy of this order. The writ petition is disposed of accordingly. No costs.

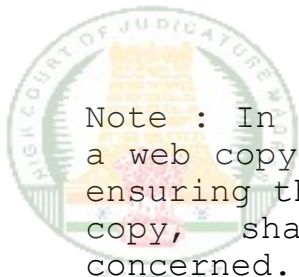
