Prayer in WP(MD). 16774/ 2021 :

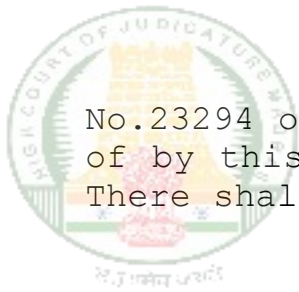
