PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

For Anticipatory Bail in Crime No.837 of 2021 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioner apprehending arrest at the hands of the respondent police for the offences punishable under section 380 IPC in Crime No. 837 of 2021 on the file of the respondent police, seeks anticipatory bail.

2.On perusal of the records it is seen that this Court by order, dated 04.02.2022 directed the petitioner to appear before the respondent police and co-operate with him to complete the investigation and on that ground interim anticipatory bail was granted for a period of two months. After the above said order, the petitioner also appeared before the respondent, but, the statement has not been recorded from him. It is sated that the final report was ready and taken on file in C.C.No.162 of 2022.



3.The learned counsel for the defacto complainant stated that the petitioner is a prime accused in this case and the balance sale consideration of worth Rs.8,00,000/- was not yet recovered.

4.Since the final report made ready, the interim order already granted by this Court is made absolute and the petitioner shall appeared before the committal Court on the date of hearing.
