2.Today, when the matter was taken up for hearing, the learned Additional Government Pleader appearing for the respondents 1 to 4 has produced a communication in Na.Ka.No.217/2018/The2, dated 17.09.2022, of the Block Development Officer, Thiruparankundram addressed to him and submitted that the charge of misappropriation levelled against the fifth
