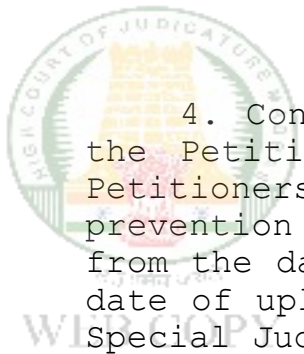

2. It is the submission of the learned Counsel for the Petitioners that there had been wordy quarrel, for which case and counter case has also been registered.

3. The learned Government Advocate(Crl.Side)would submit counter case has also been registered. He would also submit that the injured has been discharged from the hospital



4. Considering the submissions made by the learned Counsel for the Petitioners, this Criminal Original Petition is allowed. The Petitioners are directed to surrender before the Special Court for prevention of SC/ST Act Cases Pudukkottai within a period of 15 days from the date of receipt of copy of this order or 15 days from the date of uploading the order copy in the website of this Court. The Special Judge shall consider the bail application of the Petitioners and dispose of the same as per law.
