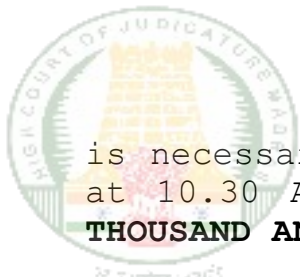
Whereas upon this day the Hon`ble Court while hearing the matter has passed an order as follows:
