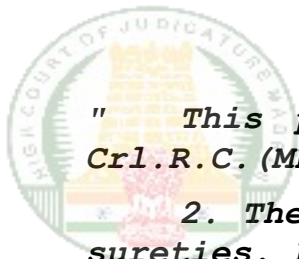
Prayer in CRL MP(MD). No.12810 of 2022:-
