### **ORDER**

This Criminal Original Petition has been filed to direct the learned I Additional District and Sessions Judge, Special Court for SC/ST (Prevention of Atrocities) Act at Trichy to consider the Petitioners' bail application on the same day of their surrender in Crime No.364 of 2022 on the file of the second Respondent.

2.When the case came up for hearing, the learned Government Advocate (Crl.Side) for the Respondents 1 and 2 would submit that the Petitioners have no previous case. He would further submit that the injured had been discharged from the hospital.

3.Considering the submissions made by the learned Government Advocate (Crl.side), this Criminal Original Petition is allowed with the following conditions:-

i) The Petitioners are directed to surrender before the learned I Additional District and Sessions Judge, Special Court for SC/ST (Prevention of Atrocities) Act at Trichy, within a period of 15 days from the date of receipt of a copy of this order or from the date of uploading the copy of this order in the official web-site of this Court.

ii) On such surrender by the Petitioners, the learned I Additional District and Sessions Judge, Special Court for SC/ST (Prevention of Atrocities) Act at Trichy, shall consider the bail application of the Petitioners and dispose of the same as per law.
