No.224 of 2022 within a period of eight months from the date of receipt of copy of that order. Subsequently, the learned Judge, Family Court, has submitted a requisition, dated 08.11.2023, stating that joint trial was ordered that the case is pending for P.W.2 cross examination and seeks four months further time to dispose of the case.

3. Considering the reasons assigned, this Court is inclined to grant four months time to dispose of the case.

4. Accordingly, the learned Judge, Family Court, Tiruchirappalli, is hereby directed to dispose of the proceedings in G.W.O.P.No.643 of 2021 and G.W.O.P.No.224 of 2022 within a period of four months from the date of receipt of copy of this order.
