Prayer: Writ petition is filed under Article 226 of the Constitution of India, to issue a Writ of Certiorari, to call for the records of the 3rd respondent in Rc.1845/2015/Sa.Pa.1, dated 17.11.2016 and quash the same as illegal.

ORDER

Heard the learned counsel for the petitioner and the learned Government Advocate for the respondents.

2.The petitioner was the President of a Co-operative Society. The 3rd respondent has issued the impugned notice dated 17.11.2016, calling upon the petitioner to show cause as to why he should not be disqualified. Without giving any reply, straight away the writ petition has been filed. It is well settled that the Court should be reluctant to interfere at the show cause notice stage. If there is *mala fide* or lack of jurisdiction, then the Court can interfere even at the show cause notice stage. Such is not the case here. The petitioner is given 21 days from the date of receipt of a copy of this order to offer his explanation to the impugned show cause notice. Thereafter, the enquiry shall be held and orders passed on merits and in accordance with law.



3.The writ petition is disposed of, accordingly. No costs. Consequently, connected miscellaneous petition is closed.
