The petitioner seeks suspension of life imprisonment imposed on him for the offence under Sections 5(1), 5(j)(ii) r/w 6 of Protection of Child from Sexual Offences Act, 2012, by the learned Sessions Judge(In-charge), Mahila Court, Pudukottai, in Spl.S.C.No.10 of 2018, vide judgment dated 26.10.2021.



2. Heard Mr.S.Karthikeyan, learned counsel for the petitioner and Mr.A.Thiruvadi Kumar, learned Additional Public Prosecutor appearing for the State.

3. Considering the seriousness of the offence as well as the age of the accused, we do not see any case for suspending the sentence at present. Hence, this Criminal Miscellaneous Petition is dismissed for the present.
