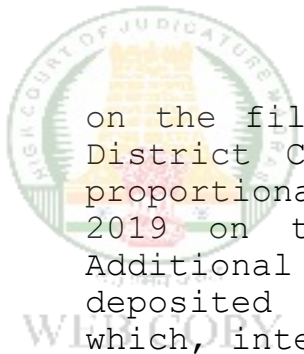

on the file of the Motor Accidents Claims Tribunal cum Additional District Court, Sivgangai, within a period of four weeks with proportionate accrued interest, to the credit of M.C.O.P.No.241 of 2019 on the file of the Motor Accidents Claims Tribunal cum Additional District Court, Sivgangai, less any amount already deposited from the date of receipt a copy of this order, failing which, interim stay granted shall stand automatically vacated.

2.Hence, this petition is disposed of.
