Writ Petition is filed under Article 226 of the Constitution of India, praying this Court (S-12) to issue Writ of Mandamus directing the respondents to pay interest at the rate of 18 percentage per annum, for the period of delay from 31.10.2019 to 22.01.2021 in paying the amounts paid towards the terminal benefits within a time frame as may be fixed by this Honble Court
