Writ Petition filed under Article 226 of the Constitution of India, for issuance of a writ of Mandamus directing the respondents to pay interest at the rate of 18 percentage per annum, for the period of delay from 31-04-2019 to 22-01-2021 in paying the amounts paid towards the terminal benefits within a time frame as may be fixed by this Court.

3.In view of the aforesaid submission, this contempt petition stands closed. However, the respondents Corporation shall furnish a copy of the calculation memo arrived by them to the petitioner and the petitioner is at liberty to challenge the same, if so advised.
