3. The learned Government Advocate (Crl.side) submits that earlier on 21.09.2022, the Tahsildar, Kadaladi, Ramanathapuram District convened a Peace Committee Meeting. Based on the report of the 4<sup>th</sup> Respondent/Inspector of Police, Keelaselvanoor Police Station, Ramanathapuram District that there are two groups in the village, recorded the fact that there is a law and order issue.

4.Considering the submission made by the learned Government Advocate (Crl.side) that in the entire District of Ramanathapuram, there is promulgation of Section 144 Cr.P.C., from 08.09.2022 to 31.10.2022, the Respondents 1 to 4 are directed to pass appropriate orders. Accordingly, this Writ Petition is disposed of. No costs.
