Prayer in WP(MD). 4185/ 2021 :

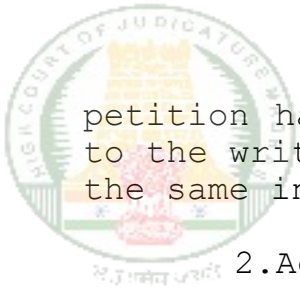
