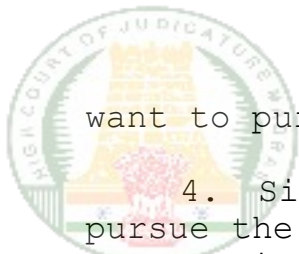

2. This criminal original petition has been filed for quashing the First Information Report in Crime No.679 of 2020 registered on the file of the first respondent.

3. The defacto complainant Thiruvenkadam is present in person before this Court through video conferencing. He has been duly identified by the police personnel attached to the first respondent police station and the same has been duly confirmed by Mr.A.Albert James, learned Government Advocate. The parties have filed a joint compromise memo. The defacto complainant states that he does not



want to pursue the matter.

4. Since the defacto complainant himself does not want to pursue the matter, no purpose will be served in keeping the impugned prosecution alive. Therefore, the impugned First Information Report is quashed. This criminal original petition is allowed. The joint compromise memo dated 14.12.2021 shall form part of the record.
