Prayer in WP(MD) . 2880/ 2020 :

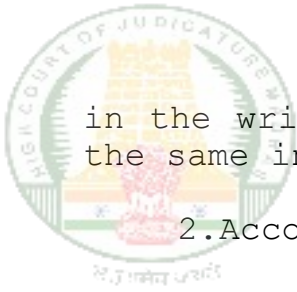
