PRAYER IN CRL A(MD) .46/2020:

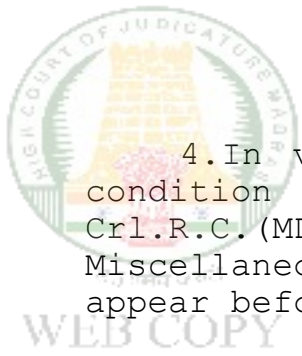
