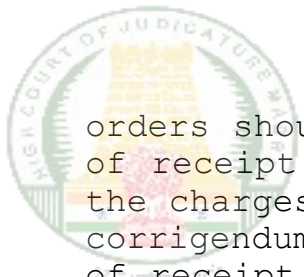

Consequently, the connected Miscellaneous Petitions are closed.
