Prayer in CRL OP(MD) . 17331/ 2022 :

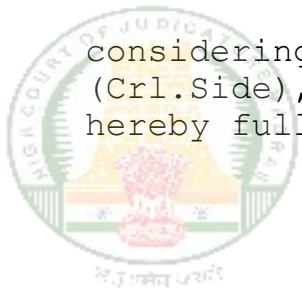
