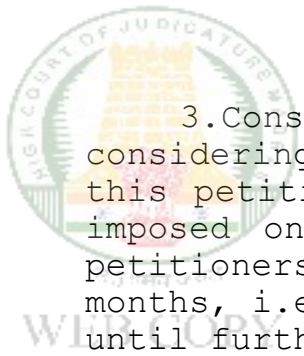
PRAYER IN Crl.A(MD)No.435 of 2019:
