2.Today, when the matter was taken up for hearing, the learned Government Pleader appearing for the respondents 1 to 4 has produced the compliance report filed by the 1st respondent and submitted that pending writ petition, a survey has been conducted on 25.10.2022 in the place in question, wherein, certain encroachments were identified. Therefore, on that day itself, eviction notices were issued to the encroachers and in compliance of the same, the encroachers / the respondents 8 to 11 themselves removed the encroachments in the place in question on 27.10.2022 and as on date, no encroachment exists in the place in question.

3.The aforesaid submission and the compliance report filed by the 1st respondent have not been refuted by the learned counsel for the petitioner.

4.Recording the aforesaid submission and the compliance report filed by the 1st respondent, this Writ Petition stands closed. No costs.
