Writ Petition is filed under Article 226 of the Constitution of India, praying this Court S-12 .To issue appropriate Writ s, Order or directions and in particular issue a Writ of Mandamus directing the respondent to pay interest at the rate of 18 percentage per annum, for the period of delay from 01/06/2018 to 21/09/2019, in paying the amounts paid towards the terminal benefits of the petitioner namely EPF Employees Contribution , Gratuity and Encashment or Earned leaves within a time frame as may be fixed by this Honble Court and without affecting his right to claim balance amounts towards those benefits and thus render justice.
