PRAYER IN CMP(MD) No.11923 of 2017 IN CMA(MD) No.1209 of 2017:

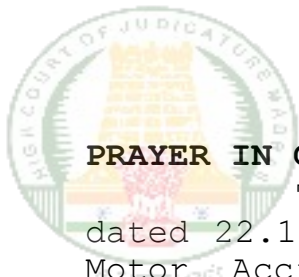
