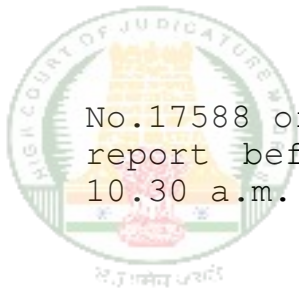
This petition has been filed to relax the condition imposed on the petitioner in Crl.O.P.(MD)No.17588 of 2021 on 19.11.2021.
