PRAYER IN CRL MP(MD)No.14563 of 2022 IN CRL A(MD)No.445 of 2022:

Petition filed praying that in the circumstances stated therein and in the petition filed therewith the High Court may be pleased to suspend the sentence and release the petitioner on bail pending disposal of this Criminal Appeal before this Honble Court against the judgment in Spl.SC.No.01 of 2021 on the file of the Honble Fast Track Mahila Court, Ramanathapuram, dated 23.04.2022

**PRAYER IN CRL A(MD)No.370 of 2022:**

To call for the entire records pertaining to the judgment delivered by the sessions Judge Fast Track Mahila Court, Ramanathapuram District in Special Sessions Case No.1 of 2022 vide his judgment dated 23.04.2022 and set aside the same and consequently acquit the appellant honourably.

Since this Court was not convicted with the merits of the case, the learned counsel for the petitioner sought permission of this Court to withdraw these petitions. He has also made an endorsement to that effect.

Accordingly, these petitions are dismissed as withdrawn. The Registry is directed to make the paper book ready and post the criminal appeal for final hearing.
