COMMON ORDER

The Writ Petitions are filed challenging the order accepting the temporary relinquishment given by the petitioners for promotion. The petitioners are at liberty to submit a copy of the representation along with the documents, if any, to the respondent, within a period of two weeks.

3. With the above direction, the writ petitions stand disposed of. No costs. Consequently, the connected miscellaneous petitions are closed.
