Prayer in WP(MD) . 6054/ 2021 :

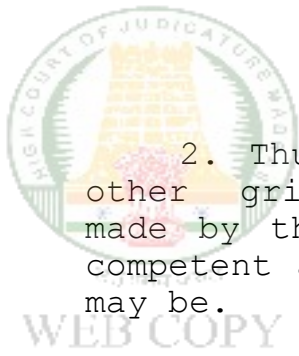
