PRAYER: Contempt Petition filed under Section 11 of Contempt of Courts Act, 1971, to punish the respondent for the willful and deliberate disobedience to the orders of this Court made in W.P.(MD) No.7214 of 2021, dated 30.03.2021.

Prayer in WP(MD). 7214 of 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court S-12. To issue a Writ or Order or Direction in the nature of Writ of Mandamus directing the respondents to pay interest at the rate of 18 percentage per annum, for the period of delay from 31.05.2018 to 24.09.2019, in paying the amounts paid towards the terminal benefits within a time frame as may be fixed by this Court.

3.In view of the aforesaid submission, this contempt petition stands closed. However, the respondents Corporation shall furnish a copy of the calculation memo arrived by them to the petitioner and the petitioner is at liberty to challenge the same, if so advised.
