Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus or direction in the nature of Writ of Mandamus directing the respondents to pay interest at the rate of 18 percent per annum for the period of delay from 30.04.2019 to 22.01.2021 in paying the amounts paid towards the terminal benefits within a time frame as may be fixed by this Honble court and pass such further or other orders as this Honble court

Learned Counsel for the petitioner though endorsed the said submission, raised certain objection with regard to the calculation of interest for the commutation amount. 3.In view of the aforesaid submission, this contempt petition stands closed. However, the respondents Corporation shall furnish a copy of the calculation memo arrived by them to the petitioner and the petitioner is at liberty to challenge the same, if so advised.
