PRAYER: Contempt Petition filed under Section 11 of Contempt of Courts Act, 1971, to punish the respondent for the willful and deliberate disobedience to the orders of this Court made in W.P.(MD) No.7342 of 2021, dated 31.03.2021.

Prayer in WP(MD). 7342/ 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court S-12. To issue a Writ or Order or Direction in the nature of Writ of Mandamus directing the respondents to pay interest at the rate of 18 percentage per annum, for the period of delay from 30.04.2019 to 22.01.2021, in paying the amounts paid towards the terminal benefits within a time frame as may be fixed by this Honble Court and pass such further or other orders as this Honble Court may deem fit and proper in the nature and circumstances of the case and thus render justice.

3.In view of the aforesaid submission, this contempt petition stands closed. However, the respondents Corporation shall furnish a copy of the calculation memo arrived by them to the petitioner and the petitioner is at liberty to challenge the same, if so advised.
