Prayer in WP(MD) . 7200/ 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ or Order or Direction or in the nature of Writ of Mandamus directing the respondent to pay interest at the rate of 18 percentage per annum, for the period of delay from 31.05.2018 to 24.09.2019, in paying the amounts paid towards the terminal benefits within a time frame as may be fixed by this Honble Court and pass such further or other orders as this Honble Court may deem fit and proper in the nature and circumstances of the case and thus render justice.
