Writ Petition filed under Article 226 of the Constitution of India, praying this Court S-12.To issue a Writ or order or direction or in the nature of Writ of Mandamus directing the respondents to pay interest at the rate of 18 percentage per annum , for the period of delay from 31/07/2019 to 27/01/2021 in paying the amounts paid towards the terminal benefits within a time frame as may be fixed by this Honble Court and pass such further or other orders as this Honble Court deems fit and proper in the circumstances of the above case and thus render justice.
