Prayer in WP(MD) . 5885/ 2021 :

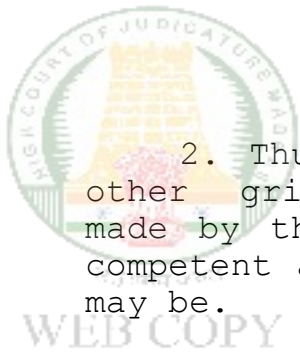
