Prayer in WP(MD) . 5899/ 2021 :

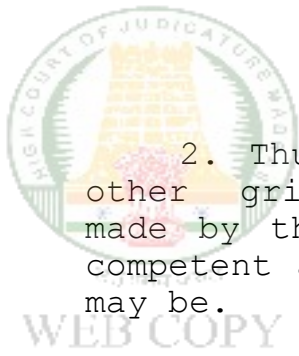
