Prayer in Crl MP(MD).No.13041 of 2022 :-

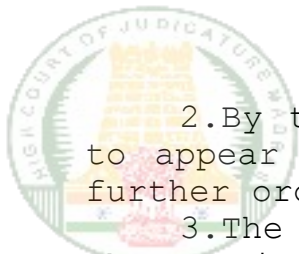
