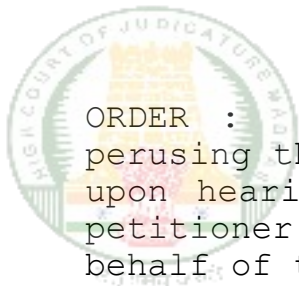

Prayer in WP(MD). 23825/ 2022 :

to issue a Writ of Certiorari, to call for the records pertaining to the impugned auction notice issued by the 1st respondent dated 09.09.2022 and the consequential auction notice published in the Tamil Daily News Paper (Dinakaran, Trichy Edition), dated 23.09.2022 in Thi.Ma.Ku.Ve.No.041/2022 in so far as the housing plot measuring to an extent of 2175 1/4 sq. feet comprised in Survey No.309/2, situated at Kalipatti Village, Singalanthapuram, Thuraiyur Taluk, Trichy District.
